

Agreement to the processing of the personal information

I hereby give the consent of the Agent and his authorized representatives to the processing of my personal information and the personal information of the persons (tourists) contained in the Application: name, surname, date and place of birth, sex, citizenship, passport number, other passport data specified in the passport; Address of residence and registration; Home and mobile phone; E-mail address; as well as any other information relating to my identity and the identity of the persons indicated in the Application in the amount necessary for the implementation and provision of tourist services, including those included in the tourist product formed by the Tour Operator, for any action (operation) or a combination of actions (Operations) performed with my personal data and the data of persons indicated in the Application, including (without limitation) collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transmission (Access to information), depersonalization, blocking, deletion, destruction of personal data, as well as the implementation of any other actions provided by the current legislation of the Russian Federation, using automation tools, including information and telecommunications networks, or without using such means, If the processing of personal data without the use of such means corresponds to the nature of the actions (operations) performed with personal data using automated means that is, it allows you to search, in accordance with the specified algorithm, for the search for personal data recorded on a physical medium and contained in card files or other systematized collections of personal data and / or access to such personal data, as well as to the transfer (including transboundary) of these data Personal data to the Tour Operator and third parties - partners of the Agent and the Tour Operator.

The processing of the personal information is carried out by the Agent and its authorized representatives (the Tour Operator and the direct executors of services) for the purpose of executing this agreement (including, depending on the terms of the agreement, for the purposes of processing travel documents, booking rooms in accommodation facilities and carriers, data transfer to The consulate of a foreign state, the resolution of claim issues when they arise, the provision of information to authorized state bodies (including on Convictions of courts and internal affairs bodies)).

I hereby certify that the personal information I transmit to the Agent are true and the Agent and his authorized representatives can process it.

I hereby give my consent to the Agent and the Tour Operator to send me e-mails / informational messages to the e-mail address and / or mobile number indicated by me.

I hereby confirm that I have the authority to provide the personal information of the persons indicated in the Application and I undertake to repay to the Agent any expenses related to the lack of appropriate authority, including losses related to the sanctions of the inspection bodies.

I agree that the text given by me on my own will, in my interests and in the interests of the persons indicated in the Application, consent to the processing of the personal information is stored electronically in a database and / or on paper and confirms the consent for the processing and transfer of the personal information in accordance with the foregoing provisions and assume responsibility for the reliability of the provision of the personal information.
